

PRIVACY POLICY

La Campera Tortilla Factory values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with La Campera Tortilla Factory of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

We reserve the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. If at any point in time La Campera Tortilla Factory decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Information We Collect

Why We Collect Information and For How Long

We are collecting your data for several reasons:

- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of

contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

Use of Information Collected

La Campera Tortilla Factory does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

La Campera Tortilla Factory may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from <https://lacamperatortillafactory.com>

La Campera Tortilla Factory may also be in contact with you with regard to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

Disclosure of Information

La Campera Tortilla Factory may not use or disclose the information provided by you except under the following circumstances:

- in other ways described in this Policy or to which you have otherwise consented;
- in the aggregate with other information in such a way so that your identity cannot reasonably be determined;
- as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of La Campera Tortilla Factory.

Non-Marketing Purposes

La Campera Tortilla Factory greatly respects your privacy. We do maintain and reserve the right to contact you if needed for non-marketing purposes (such as bug alerts, security breaches, account issues, and/or changes in La Campera Tortilla Factory products and services). In certain circumstances, we may use our website, newspapers, or other public means to post a notice.

Children under the age of 13

La Campera Tortilla Factory's website is not directed to, and does not knowingly collect personal identifiable information from, children under the age of thirteen (13). If it is determined that such information has been inadvertently collected on anyone under the age of thirteen (13), we shall immediately take the necessary steps to ensure that such information is deleted from our system's database, or in the alternative, that verifiable parental consent is obtained for the use and storage of such information. Notice to European Union Users

La Campera Tortilla Factory's operations are located primarily in the United States. Security
